3. Shoplifting, taking drugs, drinking of alcohol (under 18 years of age), or consistent misbehaviour will not be tolerated. Students are subject to English law whilst in England.
4. Any damage incurred by the student to school or host family property will be invoiced to the student's parents/guardians.
5. Students International Limited has full public liability insurance but each student is advised to have personal cover for accidents, lost luggage, damage to computers, etc.
6. Where Students International purchases flight or rail tickets for students, parents are asked to refund the full amount immediately by payment to the local bank of Students International or the main account at the HSBC Bank, UK.
7. All invoices should be settled by the due date.
8. Students are responsible for ensuring that their travel documents and visas (where required) are complete and up-to-date. Students International Limited will help with the paperwork required for visa applications.
9. One term's notice of cancellation is required. If notice is not received, a cancellation fee of £200 will be required.
10. Any disputes or claims between Students International Limited, the students, or their parents/guardians will be subject to British law through the Leicestershire Court.
